### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Plugged well back from 3046' to 2774' with 130 sacks Incer Cement. Job finished 7:30 PM 12-5-44. Drilled out cement to 3009' but failed to straighten hole. Plugged back 3009' to 2825' with 300 sack Incer cement. Job finished 12:10 PM 12-31-43. Hole straightened and at 3007' was off 1 1/2", at 3000' off 1 1/2". Now drilling at 3270' with hole off 1 1/2" at 3030'.
