Detailed account of work done, nature and quantity of materials used, and results obtained.

Drilled 8 3/4" hole to depth of 650'. Set 7" casing and circulated cement. Reduced hole to 6 1/2" and drilled to 741'. Cored with 6 1/8" diamond core barrel from 741' to 850. Ran 4 1/2" casing to 850' and cemented with 75 sacks of cement. Ran a Lane & Wells log and perforated 800' to 810' and 830' to 840'. Fraced with 325 bbls. of oil and 19,000 lbs. of sand. Well flowed back frac oil at rate of 5 bbls. per hour. Put well on pump on October 1, 1960, which was first production for this well. It is producing at the rate of 12 ~~11~~ bbls. per day.
