Dear Mr. Armstrong:

In accordance with your letter of January 20, 1961 regarding the two wells we drilled in Chaves County, New Mexico, being the Blackwell No. 1 in SE-SW of Sec. 20-10-S-25E and the Cannon No. 1-A in NW-SW of Sec. 17-10-S-25E, we are enclosing the following forms on each of these wells: Form C-102, 103 and 105, and one copy of the electric log on each of these wells.

Regarding the Well Record (C-105) on the Blackwell, we have been unable to fill in the formation log, since Peters Drilling Company drilled this well for us and we have been unable to secure the formation log from that company. However, the electric log is attached as stated above.

It is our intention to go back into both of these wells within the next two or three months and drill out the cement plugs and test the San Andres Lime drilled above where coring operations began. By these forms on these two wells we are asking for approval for temporary abandonment of these two wells, rather than final plugging.

We trust that this meets with your approval, and wish to apologize for being so long in filing these reports, but we had originally planned on doing back in these wells before now.
