This application for a permit to drill an oil and gas exploration well is hereby approved provided that all rules and regulations of the State Engineer governing the drilling and plugging of artesian wells be complied with, and further provided that:

- 1. That the 10 m casing to be used shall be not less than 40# per foot. A.P. I. pipe, and if used pipe, that same be inspected and approved by the Artesian Well Supervisor before the setting of said pipe.
- 2. That at the time of the setting of pipe, the Artesian Well Supervisor be notified in advance that he may be present to inspect said work.
- 3. That 20 sacks of oil field cement be used in setting the 10# into the Pecos formation, and that 72 hours must pass before resuming operations. Further, that 10 sacks of cement of the oil field type be used in setting the 7" O.D. pipe into the Nogal formation, and the required time of 72 hours must pass before resuming operations.
- 4. That at no time shall the artesian water be allowed to escape from the artesian aquifer after the 7" pipe be set. That the company of New Ruseell & Wood have a definite understanding with the drillers and have a definite understanding with the drillers and workmen, that no artesian water shall be used from this well for any purposes whatsoever, including irrigation, drilling uses, etc.
- 5. That the permitees hereby agree that should any of the above regulations be violated that this permit shall be revoked immediately and the well plugged in accordance with the rules and regulations of the State Engineer.
