DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED


Drilled to a total depth of 1213'. Set 31 Joints of 2-5/8" casing, 32# at 1212'. Cemented with 750 sacks 50-50 Posmix, 4% Gel, plus 1# per sack tuff plug, cement circulated to surface. Plugged down 12:30 P. M. November 20, 1954. W. O. C. until 12:30 P. M. November 22, 1954. Drilled plug at 1:30 P. M., tested with 2,000# psi for 1 hour. No loss in pressure, continued drilling.
