Drilled to 282', set 276' of 7-5/8" casing, 26.40#, cemented with 110 sacks cement, 50-50 posmix, 4% gel, plus 1# tuff plug per sack. Cement Circulated, W. O. C. 24 hours. Drilled plug, tested casing with 1,000# cold water pressure for 1 hour. No loss in pressure. Resumed drilling at 8:00 A. M. 2-12-56, now drilling at 681' in hard lime, preparing to run 5-1/2" casing. Top of lime 650'.
