## DETAILS OF WORK

Will drill 6-3/4" hole to the top of the Queen sand expected at 750 feet, then core ahead to the bottom of the queen.

If well is commercial, will ream hole to bottom, run 4 1/2" casing, cement and gun perforate.

Notice of intention to change plans will be filed after coring if commercial.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

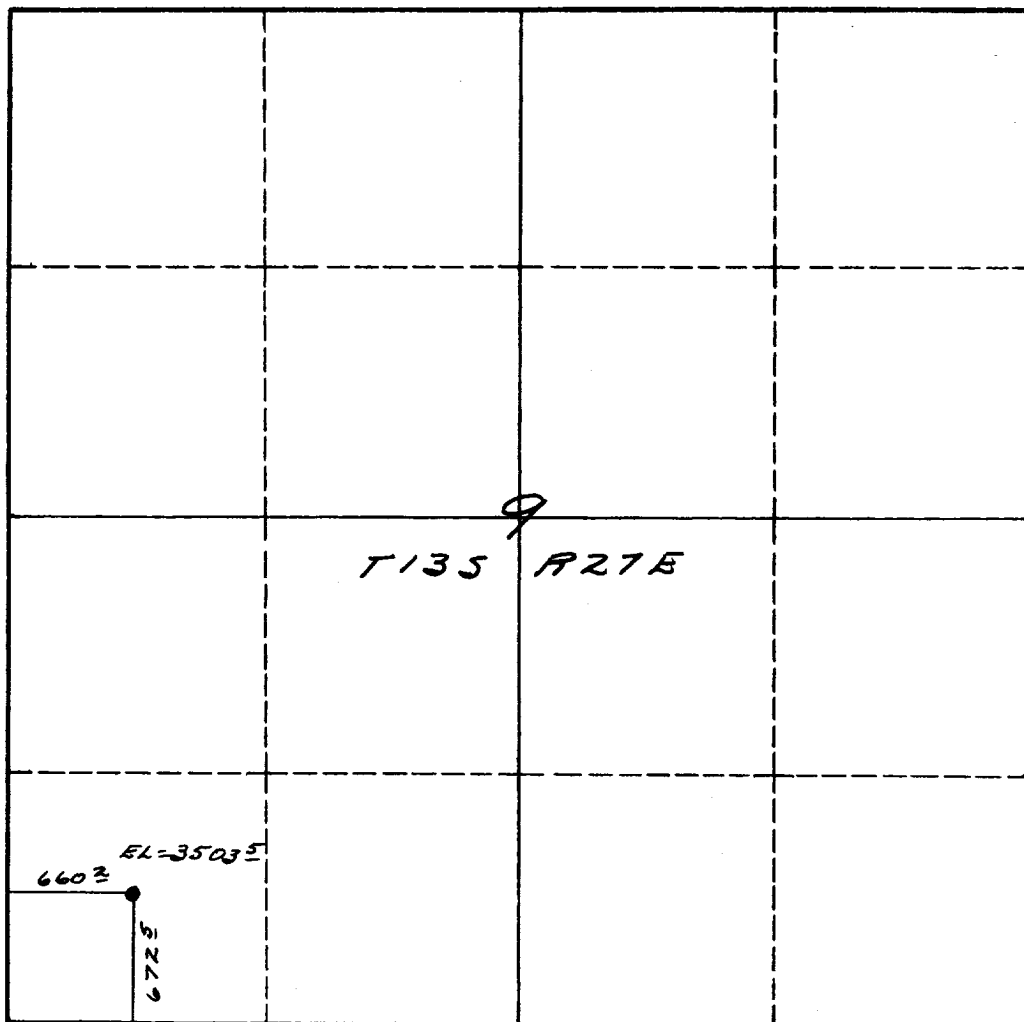
