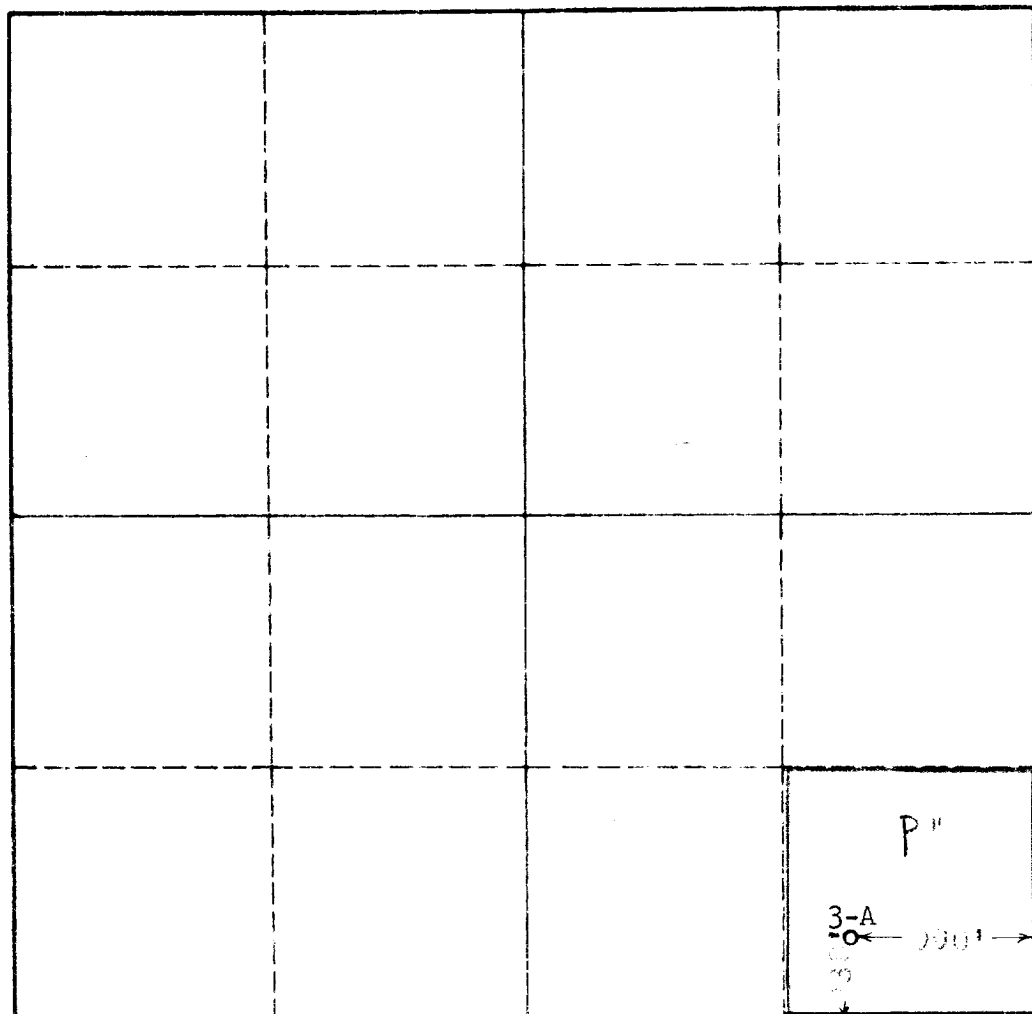


Gentlemen:
