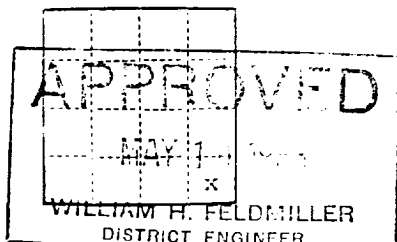

Dear Mr. Feldmiller:

As per your letter of January 23, 1963 to me I have abandoned and plugged and completed cleaning up lease for your information and approval. Hinkle Federal No. 1, SE1/4 Sec 17, T. 11 S., R. 27 E., N.M.P.M., lease New Mexico 01123, and the Hinkle Federal well No. 1, NE1/4 sec. 20, T. 11 S., R. 27 E., N.M.P.M., lease New Mexico 02330-A. On January 31 pulled rods and tubing taking out perforations in tubing. Put tubing back in hole filled with mud, then put ten sacks in bottom of each well. Pulled tubing to about 100 foot top of hole and put in four sacks of cement in top of each well into the markers. All this work was done on Jan 31 and Feb 1st. 1963. Cleaned leases and filled pits the next week.

McWood Corporation took the oil from the tanks on these lease Feb 3rd. Please send me som blank forms for runs and sales of oil that I am fill them in for February.
