We propose to follow this procedure to re-enter the well: *P&A 5-48*

- 1) With a reverse unit we will drill through a 30 sack cement plug at the surface and clear out hole to 2500' through 13-3/8" and 8-5/8" casing, Drill out a 5 sack cement plug to the top of the 7" casing at 2510'.
- 2) Mill off damaged 7" stub and run new 7" string and connect with old string.
- 3) Clear out remainder of the hole and run logs.
- 4) a. If determined a producer, we will plug back to producing zone and run 4-1/2" oil string.

b. If dry hole we will P&A as required by NMOC rules and regulations.

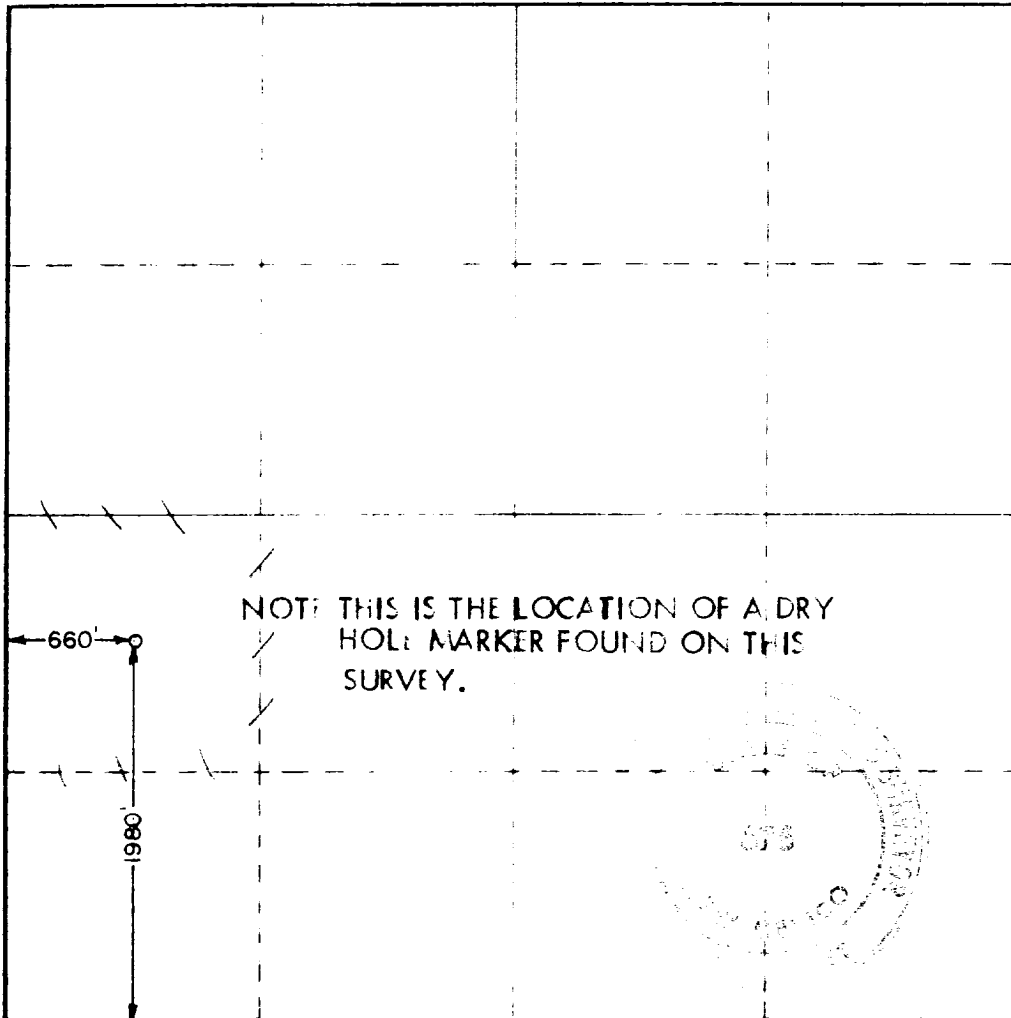
