7/19/79 Set CIBP @ 8350' w/35' of cement on top w/dump bailer shoot off 4 1/2" casing @ 5600', lay down 4 1/2" csg. Go in hole w/tubg, displace hole w/25# salt gel/bb mud

7/20/79 Spot 150' plug 75' in & 75' out of stub of 4 1/2" csg, tag plug w/tubg, if holding proceed, if not, respot plug.

7/21/79 Spot 100' cement plug from 3800 - 3900, spot 100' cement plug across shoe of 8 5/8" 2050 - 2150; tag this plug w/tubg.

7/22/79 Spot 15-20 sx plug in surface; Erect dry hole marker w/sack-crete. Rig down plugging unit, clean location.

7/23/79 Restore surface in accordance w/BLM specifications.
