DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The well was spudded at 8:00 A.M. on 1-15-53 by Trinity Drilling Company and a 16" hole drilled to 100'. Ran 76.23' of 13 3/8" surface casing and set at 89.23'. Cemented casing with 150 sacks of regular cement, circulated 60 sacks and left 15' plug in the bottom of casing. Plug was down at 8:00 P.M. on 1-15-53. After waiting 24 hours on cement, casing was pressured up and held. Started drilling out plug at 9:00 P.M. on 1-16-53.
