Well E-92 No. 11 is in a temporary abandoned condition at this time. The previous operator of this well drilled it and set pipe but never produced it because of sand difficulties. Since taking over we have cleaned the well out and logged it but were unable to produce any fluid from it. Depending upon the success of our water flood we may request that this well be converted to injection.
