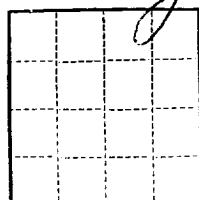

DETAILS OF WORK

We propose to:

1. Drill 11" hole to approximately 100'.
2. Run approximately 100' of 8 5/8" OD casing and cement with 50 sacks.
3. Drill to approximately 1500' with 6 1/2" bit.
4. If warranted we propose to run approximately 1500' of 4 1/2" OD casing and cement with 75 sacks and complete through perforations.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

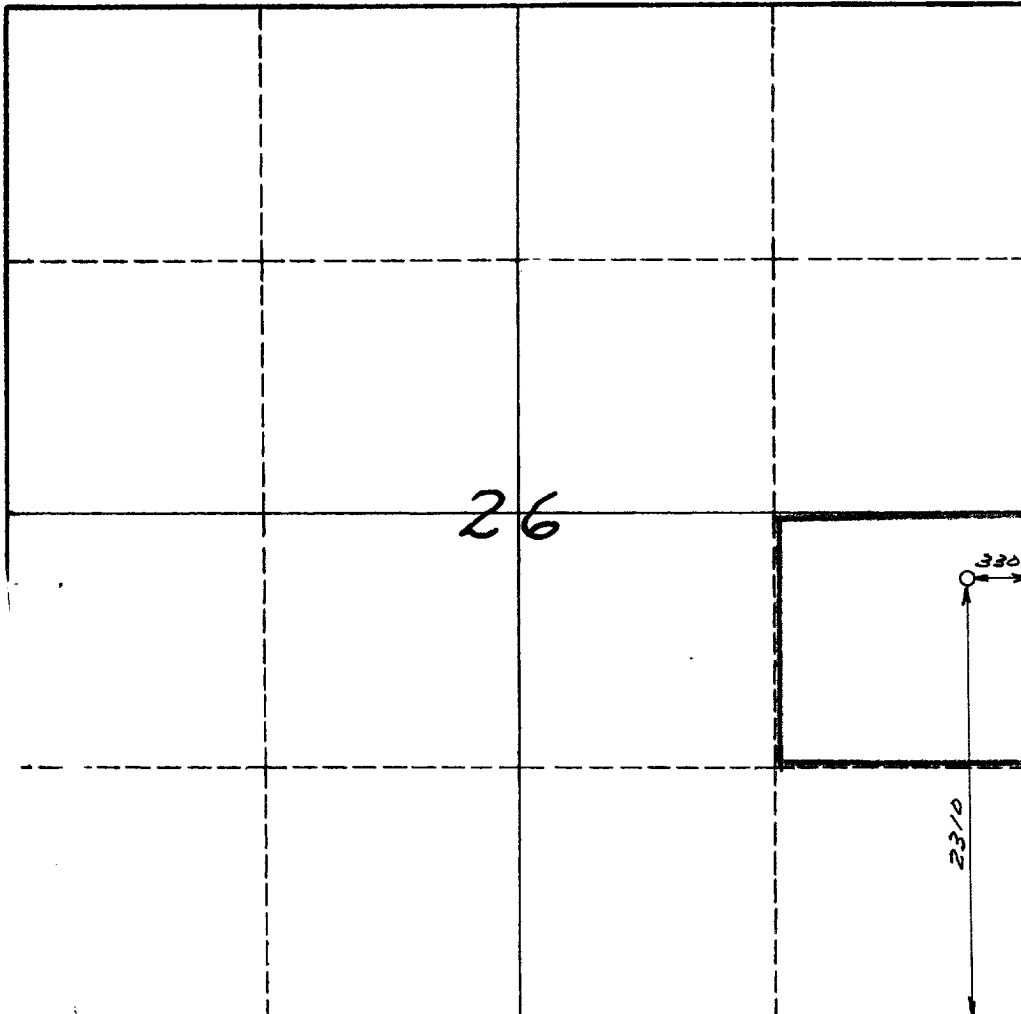
