At total depth of 6,315' 4 1/2" O.D. 9.5# J-55 new casing was cemented at 6,143.75' with 175 sks. of Inconel cement. Plug was pumped down at 2:50 P.M. 4-15-65. Top cement behind 4 1/2" casing indicated by temperature survey to be at 5,200' at 11:00 P.M. when pressure was released. After more than 8 hours W.O.C. 1500# PSI was applied and held for 30 minutes without loss.

Instructions
