1. Ran 2" tubing, spotted 200 gallons 15% BDA on bottom, pulled tubing.
2. Ran GR/CCL log 2602'-1800'.
3. Perforated 2544-2549', 2553-2559', 2563-2566', with 6 BSPF (0.47" entry).
4. Injected acid plus additional 1000 gallons 15% BDA.
5. Swabbed 100% water (45 BW in 4 1/2 hours).
6. Ran 2" tubing to 2585' with SN at 2554'.
7. Treated with 1000 gallons 15% BDA with Fe additive.
8. Hung 65 joints (1963') 3 1/2" OD, 9.3#, J-55, EUE tubing at 1968' with pump barrel 2585-2601'. Ran 2 3/4" x 5' fluid packed tubing pump on 77-3/4" rods and 24 subs and 5' pump plunger.
9. Pumped 13 BWPH on 12-64" SPM.
10. Shut in.
