Your Notice of Intention to Drill well No. 1 Grant Keyes, SW\(^1\)SW\(^1\) sec. 20. T. 6.S., R. 26 E., N.M.P.M., Chaves County, New Mexico, Federal lease New Mexico 022685, is approved subject to the running and cementing of an intermediate water protection string if artesian aquifers are encountered.
