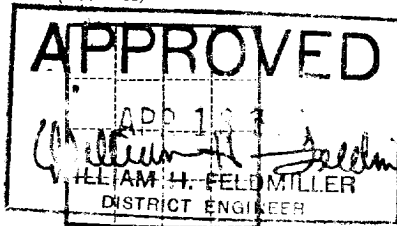

DETAILS OF WORK

Plan to drill with rotary tools to test the San Andres formation at approximately 1400 feet. Will run 7" casing to approximately 100' and cement with a volume sufficient to circulate to surface. Will core San Andres Pay Zone. If commercial pay is encountered will run 4-1/2" production string and cement with approximately 50 sacks of cement.
