1. Set 25 sack plug at T.D. across perfs 2623-60' up to 2520'.
2. Jet cut 4½" casing at 1600' and set 35 sack plug 1650'-1550'.
3. Set 35 sack plug in and out of 8-5/8" at 1005' to 905'.
4. Set 10 sack plug at surface and installed regulation marker.
5. Will inform when location is cleaned up and ready for inspection.
