3. POH.
4. Cut 4 1/2' @ 5023' approx. 3650'
5. Set 25 sxs cement plug across 4 1/2' stub 5073' to 5023' minimum 100'
6. WOC Tag Plug.
7. Set 50 sxs cement plug across 8 5/8' shoe 1822' to 1722'.
8. WOC Tag Plug.
9. Set 30 sxs cement plug 150' to surface.
10. Brine gel between all cement plugs. Notify BLM to Witness plugging operations.
11. Install dry hole marker and clear location.

McKay Oil anticipates having this well plugged and abandoned on or before March 31st, 1999

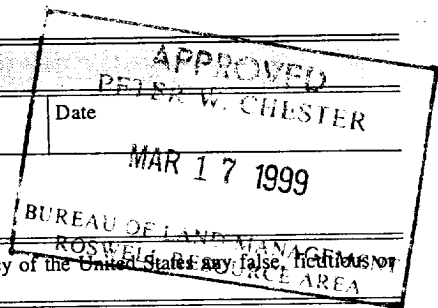
