6. Set 100' cmt plug @ 1650-1750'. 1400' to 1500'
7. Set 100' cmt plug @ 960-1060'.
8. Circ cmt from 175' to surface.
9. Cut off wellhead & install dry hole marker.

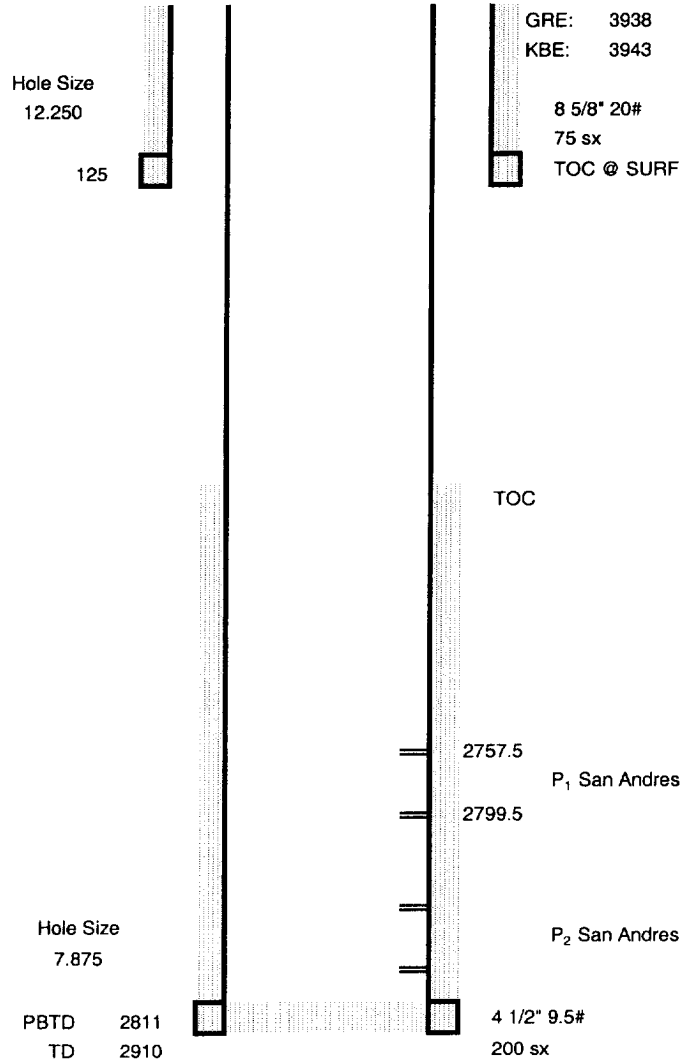
