Spud date 12-2-81. Drilled with cable tools to an approximate depth 200'. Operator reportedly set 17" casing at a depth of 60' with 25 sacks. Encountered surface water while drilling and hole filled with water to a depth of approximately 50'. It is believed that no further drilling was accomplished. Rig moved off location around March 13th or 14th. No shows of oil or gas were encountered.
