Set 40' of 20" conductor pipe. Spudded 14-3/4" hole at 12:30 PM 12-10-81. Ran 22 joints of 10-3/4" 40.5# J-55 casing set at 925'. 1-Texas Pattern guide shoe at 925'. Flapper insert float at 883'. Cemented w/400 sacks Pacesetter "C" 3% CaCl<sub>2</sub>. Tailed in w/300 sacks Class "C" 2% CaCl<sub>2</sub>. PD 11:45 PM 12-12-81. Bumped plug to 1000 psi, released pressure and float held okay. Cement circulated 35 sacks to pit. WOC. Drilled out at 6:45 PM 12-13-81. WOC 18 hours. Nipped up and tested to 1000 psi, OK. Reduced hole to 7-7/8". Drilled plug and resumed drilling.
