1. The following state or pertinent laws, and their pertinent date, shall be included in the State Bar of Michigan's annual report to the public:

Spudded a 17-1/2" hole on January 28, 1982 and drilled to 350'. Ran and cemented 13-3/8", 48#, H-40, at 350' with 240 sacks Class "H" + 2% CaCl₂ + 3#/sack Silt + 17#/sack floccle. Circulated cement to surface. Waited 19 hours on cement. Drilled a 12-1/4" hole to 2800'. Ran 9-5/8" casing to 2785' and cemented with 970 sacks light cement followed by 200 sacks Class "C". Circulated good cement to surface. Installed 9-5/8" x 3000 psi wellhead and BOP equipment. Waited on cement 21 hours. Tested casing to 750 psi and BOP equipment to 3000 psi. Presently drilling 8-3/4" hole at 2823'.
