This well will be plugged as follows:

- Set CIBP @ 3800' and cap with 35' cement plug.
- Equalize 100' cement plug inside 4-1/2" casing from 1870' to 1770'.
- Perforate @ 1000' and equalize 75 sk plug inside and outside 4-1/2" casing. TAG
- Cut off casing strings 2' below ground level.
- Lay 10 sk plug inside 4-1/2" casing at surface.
- Leave salt gel mud mixed with 25#/bbl brine water between plugs.
- Install dry hole marker 4' above ground level.
- Cut off anchors and flow line 1' below ground level.
- Clean and level location.
