Drilled 9 7/8" hole to 1723' with 9.6# mud, NU BOP's and tested to 600 psi for 30 mins - OK. Reduced hole to 7 7/8" and drilled ahead on 4-6-82. Drilled to TD of 4100' on 4-10-82. Ran 96 jts 4 1/2", 10.5#, K-55 casing set @ 3889'. Cemented with 400 sx HLW + additives and tailed in with 300 sx "C" + 5# KCL + 3/10% HALAD-4 + 2/10% CFR-2. PD @ 4:30 PM 4-11-82. Cement did not circulate. Released rig at 12:01 AM 4-12-82. WOCU estimated to arrive 4-19-82.
