
Gentlemen:

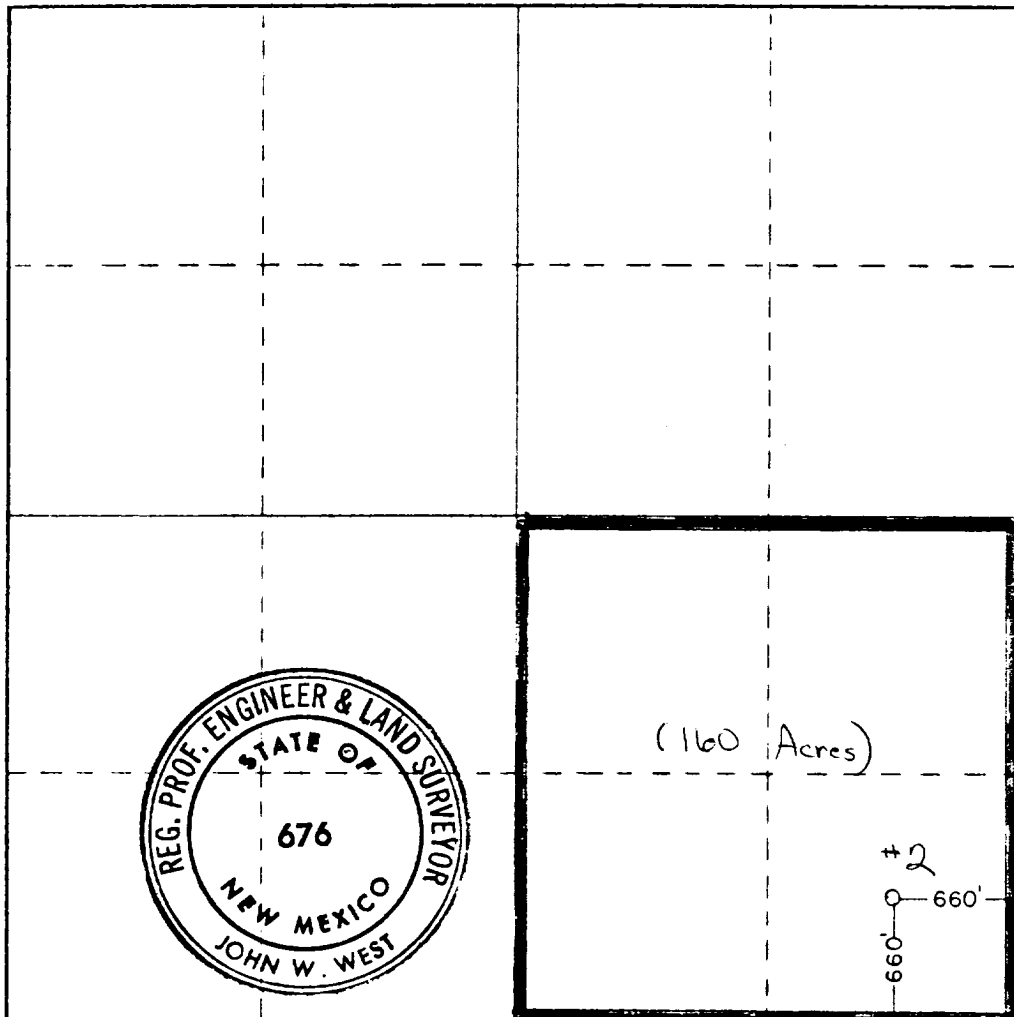
