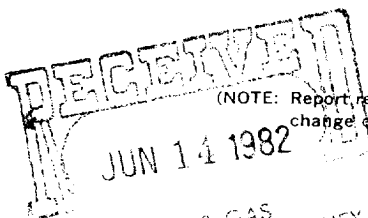

Spudded well with 12 1/4" hole on 6-6-82. Drilled on air to 1481' and ran 38 jts 8 5/8", 24#, K-55 casing set at 1480'. Cemented with 700 sxs Thixalite + 1/4#/sx flocele + 4% CaCl and tailed in with 200 sxs Class "C" + 2% CaCl. PD at 9 PM, 6-7-82. Cement did not circulate. Ran temperature survey --- TOC at 490'. Set five plugs with a total of 700 sxs Thixset + 4% CaCl to circulate cement. Tested BOP's and casing to 600 psi for 30 minutes --- OK. Reduced hole to 7 7/8" and drilled ahead on 6-8-82. WOC total of 26 hours.
