12/08/89: Ran Tbg. & S.N., tagged top of sand @ 3,672' KBM (385' of fill), RU reverse unit & cleaned out to 4,057' KBM, set Tbg. @ 3,993' KBM, swabbed & recovered 55 Bbls. frac wtr.

12/09/89: Swabbed & Tbg sanded up, could not get to S.N., ran sinker bar to 3,933' KBM, POH & shut down.

12/11/89: Freed up stuck Tbg, pulled 5 stands of Tbg & shut down due to weather.

12/12/89: Ran 1 stand of tbg., PU broke down.

12/13/89: Swabbed-well kicked off flowing water & lots of sand, sand cleaning up towards end of day, swabbed & flowed a total of 220 bbls.

12/14/89: TIH letting gas & sand blow to pit while lowering Tbg, blowed all sand off of perforations to 4,005' (S.N. @ 3,994' KBM), killed well & made up wellhead, swabbed well back in, swabbed & flowed a total of 310 bbls. wtr. in the last 24 hrs.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
