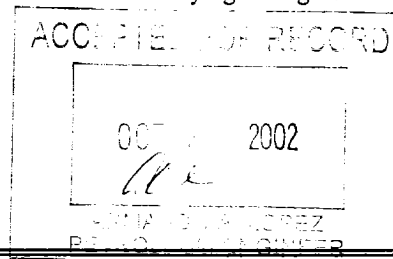

9/9/02 Move in and rigged up pulling unit. Nippled down BOP. Released packer. Tagged sand at 4136'.
9/10/02 TIH with cement retainer on tubing. Set at 3691'. Squeeze off Abo perms with 200 sx "H" cement at 16.5#. Abo squeezed off at 2250#. Sting out. Circulated out 2 bbls cement.
9/12/02 TIH with 3-7/8" bit and collars. Drilled cement retainer and 50' cement. TOOHH with bit. Bit was bad.
9/14/02 TIH with new bit. Drilled out cement. Fell of out cement at 4040'.
9/16/02 Cleaned out to FC. Drilled FC and 15' cement to 4220'. Circulated hole clean. TOOHH laying tubing down. Rigged down pulling unit. Turned well over to drilling.
