2.) Test CIBP and casing to 500 psi.  
3.) Spot 10 sx cmt. on CIBP and load hole w/9.5 ppg mud laden fluid.  
4.) Set a 25 sx plug from 2,300'- 2,450'.  
5.) Set a 25 sx plug from 1,100'- 1,250'.  
6.) Set a 10 sx surface plug from 3'- ~~25'~~ 53'.  
7.) Cut off wellhead 3' below ground level and weld on a steel plate and P & A marker.  
8.) Clean location and restore to pre-move condition.
