- 1) Set a 25 sack cement plug from T.D. to 2150 to cover Slaughter zone.
- 2) Tag plug & fill hole with mud.
- 3) Set a 25 sack plug at top of San Andres (1628) from approx 1578 to 1676.
- ★ 4) Set a 25 sack plug at top of Queen (952) from approx 900 to 995.
- 5) Set a 35 sack plug at base of Surface Casing (356) approx 300 to 432.
- 6) Set a 10 sack plug at surface and install a dry hole marker.
