Commenced Drilling @ 10:15 May 15, 1989. Drilled A 12 1/4" hole to 430' and encountered very little water. Ran 421' of 8 5/8" 20 # casing with 2 centralizers, an insert Float and Texas pattern guide shoe. Cemented casing with 250 sacks of Haurburton Premium Plus cement with 2% CoCl. Circulated 60 sacks of cement to pit. Pumped plug to Float and pressured casing to 600psi and held for 30 minutes, pressure held. W.O.C 18 hrs
