Bumped plug to 1500 psi, released pressure, held okay. Perforated 2937-3074' w/20 - .40" holes as follows: 2937, 38, 39, 40, 41, 42, 43, 82, 83, 84, 87, 88, 89 and 90' (1 SPF); 3071-74' (2 SPF). Acidized perfs 2937-3074' in three stages w/2250 gals 15% acid. Frac'd perfs 2937-3074' (20 holes) w/60000 gals gelled 2% KLC water and 100000# 20/40 sand.
