08/03/89: T.D. 14-3/4" hole @ 913' KBM @ 9:15A.M., 8-3-89. Left 3-cones in hole, fished & recovered cones.

08/04/89: Ran 23 Jts. 10-3/4" OD, 40.5#/ft., J-55, ST&C (Used) Csg, 902' set @ 913' KBM. Cemented w/400 Sxs. Pace Setter Lite cement + 1/4# cellophane + 6% gel + 3% salt/sx., followed w/200 Sxs. Class "C" + 2% calcium chloride. Plug down @ 9:15A.M., 8-4-89. Circulated 100 Sxs. good cement. Mr. Vic Coats w/BLM witnessed. WOC 18 hrs. Nippled up BOP. Tested Csg to 1,000 psi - okay, tested BOP to 1,000 psi - okay.

08/05/89: Tested blind rams to 1,000 psi - okay, opened BOP & one blind ram did not retract. Found guides in BOP worn out. Nippled down & removed BOP. Nippled back up w/replacement BOP. Tested blind rams to 1,000 psi - okay, opened blinds & one ram failed to retract. Cleaned up rams & recheck, okay. Ran bit & tagged top cement @ 864'. Closed pipe rams & pressure tested pipe rams & Kelly Cock to 1,000 psi for 30 min. - held okay. Mr. Vic Coats w/BLM witnessed tests. Drilled cement, shoe & commenced drilling 9-7/8" hole.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
