07/26/89: Ran 45 Jts. 7-5/8" OD, 26.40#/ft., N-80, LT&C Casing, 1,880' set @ 1,890' KBM. Cemented w/175 sxs. Pace Setter Lite + 6% gel, followed with 100 Sxs. class "C" Cmt. + 2% calcium chloride. Plug down @ 12:00 noon, 7-26-89. Set slips, cut off & welded on 7-7/8" head. Nippled up. Ran temperature survey, found top of cement @ 1,540', tested blind rams to 1,000 psi for 30 Min. - held okay, trip in hole to 1,514' and tested pipe rams to 1,000 psi for 30 Min. - held okay. Tested Kelly Cock to 1,000 psi for 30 min. - held okay. Ran straight hole survey, tagged top Cmt. inside Csg @ 1,794'. Drlg. Cmt., float collar & shoe. Commenced drilling 6 $\frac{1}{2}$ " new hole @ 5:00AM, 7-27-89. Mr. J.R. Hogwood with the BLM witnessed.

07/27/89: No fluid loss, the past 24 hrs.. Depth 2,700'.

07/28/89: No fluid loss, the past 24 hrs.. Depth 3,314'.

07/29/89: Mud up @ 3,500'. Hole condition good. No fluid loss last 24 hrs.. Depth 3,736'.

07/30/89: Drlg. breaks: 3,725'-44, 3,760'-69, 3,915'-26 & 3,962'-69, broke from 5 $\frac{1}{2}$ min./ft. to 2 Min./ft.. T.D. 6 $\frac{1}{2}$ " hole @ 4,050' @ 6:00AM, 7-31-89.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
