, said well being drilled to test for hydrocarbons and/or carbon
dioxide gas and described as the Osage "33" Com. No. 2 Well, being located 990 feet from the North line and 1,650' feet from the West line of Section 33, Town-
ship 6 South, Range 26 East, NMPM, Chaves County, New Mexico.
3. Inat said well was drilled to a total depth of 4,250feet and that casing has
been set and cemented as follows: 13 3/8" 61# set at 79' w/cement circulated to surface and 8 5/8" 24# J55 casing set to 773' w/cement circulated to surface.
4. That operator and landowner have made an agreement whereby operator (is not)
to back fill pits, level location, and clear it of all junk. The agreement further pro-
vides that operator is to plug said well back to a plugged-back total depth of see below
feet and transfer well to landowner for his use as a water-well. Operator will leave casing in the well as follows: As stated in paragraph 3 above.
Cement plugs are set in the well as follows: 1, 35 sv @ 3780;-3680;
2. 45 sx @ 1675'-1500' 3. 50 sx @ 825' WOC 5 hrs. and tagged at 600' 4. 15 sx @ 50' to surface.
