Yates Petroleum Corporation is requesting a variance be granted in requiring the casing to be tested to 1500 psi to testing the casing to 1000 psi. The rig pumps will be used to do the testing.

Yates requests this due to several reasons.

1. Maximum shut-in bottom hole pressure is 1100 psi. Pressure at the surface will be less than this.
2. Rig pumps used in this area cannot safely test above 1000 psi. In order to test casing to higher pressures, an independent service casing would have to be hired. This would result in greater expense in drilling the well.
3. Yates is requesting, in the case of well drilled to Pecos Slope Abo, that BOP equipment be tested to a maximum of 1000 psi.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
