2/17/90 Ran 452' of 8-5/8" J-55, 23 lb. casing with Texas Pattern Shoe. Circulated hole with 300 sks. Class "C" Cement with plug. Approx. 100 sks to pit. Shut in for 18 hours and pressure tested casing to 750 lbs. for 30 minutes, no droppage in pressure, resumed drilling.

2/20/90 T.D. hole at 2130'.

2/20/90 Ran 2130' of 4 1/2", J-55, 10.5 lb. casing with guide shoe. Circulated hole to surface with 400 sks. of Class "C" Cement.
