Howco Lite + 1/4# flocele per sack mixed @ 12.1#/gal., followed by 250 Sxs. Premium Plus + 2% CaCl2 and 1/4# flocele per sx.. Plug down @ 12:00PM, 3-18-91. Circulated 112 Sxs. good cement. Notified Mr. J.R. Hogwood with the BLM prior to running 10-3/4" surface casing, did not witness. WOC.

03/19/91: WOC 15 hrs.. Nippled up. Tested BOP blind rams and choke manifold to 1,000 psi for 30 Min.-held. Tagged cement @ 840'. Tested Kelly cock & pipe rams to 1,000 psi for 30 Min.-held. Mr. J.R. Hogwood w/BLM notified, did not witness. Now drilling 9-7/8" hole @ 910'.

03/22/91: Drilled 9-7/8" hole from 910' to 1,829', encountered no problems. Reduced hole to 7-7/8" @ 1,829'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
