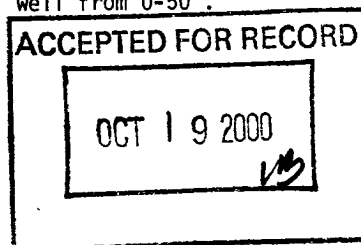

9-30-00 Perforate 4½" casing @4855, 1500', 350' and 50'. Pumped 50 sx plug at 6050', woc 2 hrs. and tag plug @6010'. Pump 35 sx plug @4855'. Pump 35 sx plug @1500', POH and SDFN.
10-2-00 RIH and tag plug @1320', pump 35 sx plug @350'. Pump cement to fill well from 0-50'.
Install dry hole marker.
