Commenced drilling operations on 02/02/92 @ noon. Drilled a 12 1/4" hole to 390'. Encountered H₂S gas @ 319'. Took safety precautions (See H₂S safety plan attached). Ran 390' (9 jts) of 8 5/8" New J-55 24# casing w/ 2 centralizers, insert float and shoe. Landed shoe @ TD. Cemented well w/ 250 sx Class C w/ 2% CaCl₂, plug down @ 3:00 pm 02/19/92. Pressure casing to 500 psi and held for 30 min. Cement did not circulate. Ran temperature survey and found top of cement @ 50' (see attached survey). Filled annulus w/ 2 yds ready mix. WOC and commenced drilling 8" hole @ 8:00 am 02/21/92.
