Spud well at 5:00 P.M. on 11/07/92. Drill 12 3/4" hole to 470'. Ran 466' (16 joints), of 8 5/8", 24#, J-55 casing. Cemented with 325 sxs, Class C Premium Plus, containing 2% CaCl2. Plug down at 4:00 P.M. 11/09/92. Circulated 75 sxs. WOC 18 hours. Tested to 1000# for 30 minutes, test okay. Resume drilling a 7 7/8" hole.
