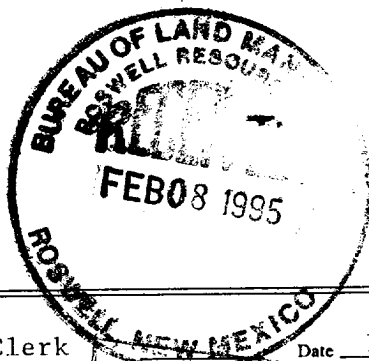
1-27-95 - Shut down.

1-28-30-95 - TIH w/Uni III packer, on/off tool and 2-3/8" tubing. Set packer at 3310'. Removed BOP and nipped up wellhead. Began swabbing around the clock.

1-31-95 - Swabbed. Shut well in.

2-1-95 - Shut in.

2-2-95 - Nippled down wellhead and installed BOP. Unset packer. TOOH with tubing and packer. Released well to production department.



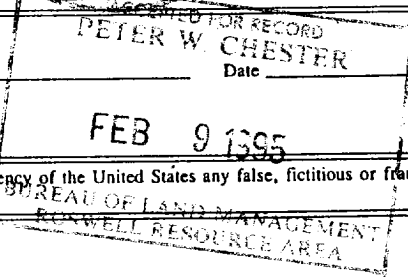
