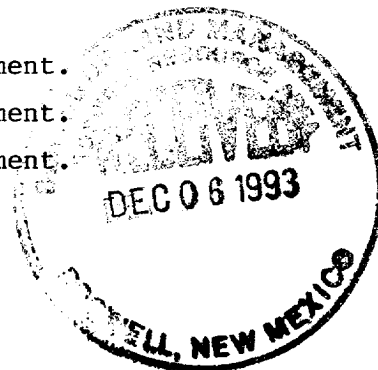

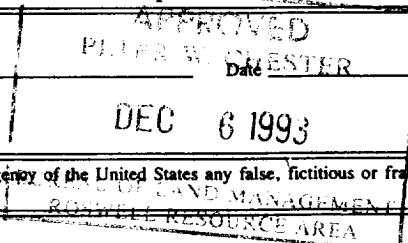

SPECIFIC INSTRUCTIONS
