- 1). Set a CIBP at 1118' to isolate perforations(1168'-1217'). Circulated well with 25# Salt Gel per BBL of mud. Set a 12sx Class "C" cement plug from 1118'-1004'.
- 2). Set a 15sx Class "C" cement plug from 664'-522'.
- 3). Set at 60' and set a 10sx Class "C" cement plug from 60' to surface.
- 4). Install Dry Hole Marker and clean location.

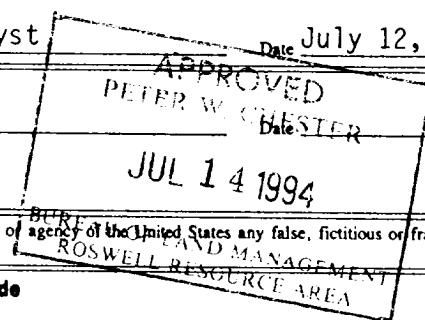
