1. Construction of Location

a. Build a small 80' X 100' reserve pit into the south and v-dooring to the west. Line pit with plastic.

b. Change the road to come into the NW corner of pad.

c. By using a berm and cutting a drainage ditch on the west side above the location we will divert any run off to the south to an existing drainage. A 18" culvert will be used where the road crosses our ditch and berm.

d. Another berm will be built on the east (Lower) side in a manner to have enough volume to hold the contents of the reserve pit.

2. Drilling of Well

a. Use reserve pit to hold fresh water to drill surface hole.

b. Use steel pits when drilling with brine water. Jet cuttings from steel pit to reserve pit as needed.

c. Mud up using steel pits.

d. After well is to T.D. run 4 1/2 casing. Have vacuum truck to suck mud from steel pits and haul to new location.

e. Have vacuum truck clean up cutting and haul to the Powers "OL" Federal #12 reserve pit.
