TIH with tapped bull plug, mud joint, 4' perforated sub, seating nipple set at 3252' and 2-7/8" tubing. Removed BOP and nipped up wellhead. Swabbed.
1-12-95 - Ran pump and rods. Nipped up wellhead. Released well to production department.
