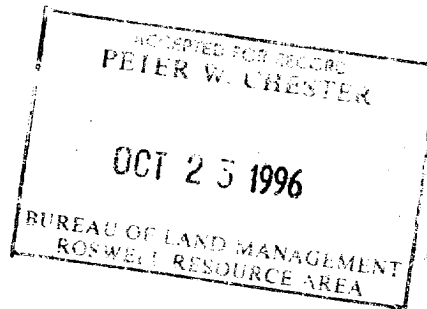

10-17-96 - TD 1630'. Reached TD at 8:30 PM 10-16-96. Ran and landed 36 joints of 8-5/8" 24# 8rd J-55 ST&C (1613.65') of casing set at 1628'. 1-Texas Pattern notched guide shoe set at 1628'. Float collar set at 1584'. Cemented with 100 sacks "H", 10% A-11, 1/4#/sack flocele, 10#/sack gilsonite and 1% CaCl₂ (yield 1.51, weight 14.6). Tailed in with 100 sacks "C" and 2% CaCl₂ (yield 1.32, weight 14.8). PD 4:00 AM 10-17-96. Bumped plug to 100 psi, OK. Cement did not circulate. Calculated to tie back to 867'. WOC. Drilled out at 5:30 PM 10-17-96. WOC 13 hours and 30 minutes. Reduced hole to 7-7/8". Resumed drilling. NOTE: Notified BLM-Roswell of cementing.
