Cemented casing w/ 375 sx Class "C" cement w/ 2% CaCl.* Plug down @ 3:45 p.m. 3/2/96. Pressured casing to 500 psi and held for 30 minutes O.K. WOC 39 hours. Commenced drilling a 7 7/8" hole 3/4/96.
